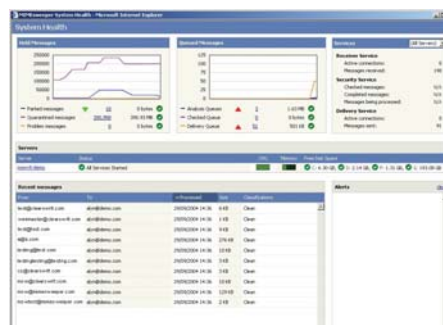

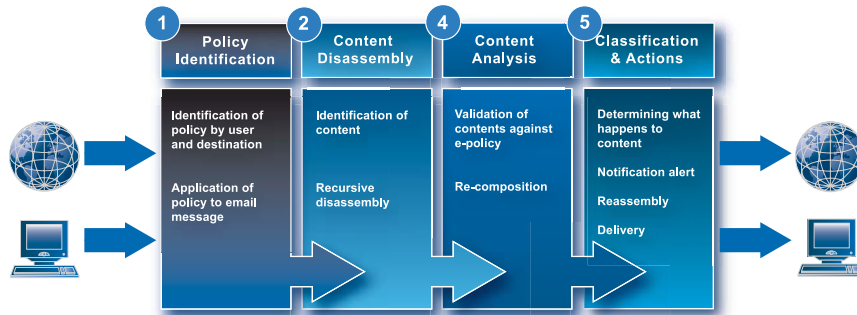

How Does It Work?

Simplify Your Administration

Management and administration tasks on security systems can be a time consuming burden for IT staff. MIMesweeper's intuitive web-based management interface provides multiple Administrators with consolidated management all from one location, thereby saving time and effort. It includes five specific management areas:

- **Systems Center** - allows Administrators to control the services running on each host and view the status of messages
- **Security Center** - where Administrators' roles and responsibilities are defined
- **Message Center** - where the majority of the day-to-day tasks are performed. This Center provides a unified view of all the different quarantine areas and message directories thus simplifying the task of managing multiple servers
- **Report Center** - where Administrators can access 20 pre-defined reports and access a powerful wizard to customize reports
- **System Health** - a single web page that shows, at a glance, a snapshot of all the systems running in the configuration. It shows message flow, counts of messages in quarantines and passing through the system and key trend information (such as queue's getting bigger or smaller)

MIMesweeper's unique approach to system management allows for hierarchical devolvement of duties to multiple Administrators. IT managers can delegate specific responsibilities, such as server monitoring, access to particular quarantine areas and reporting, to the most appropriate Administrator or department; therefore spreading the load of administration and significantly reducing the time it takes to process blocked emails.

Message Management

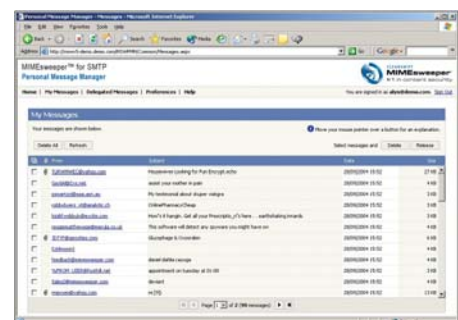

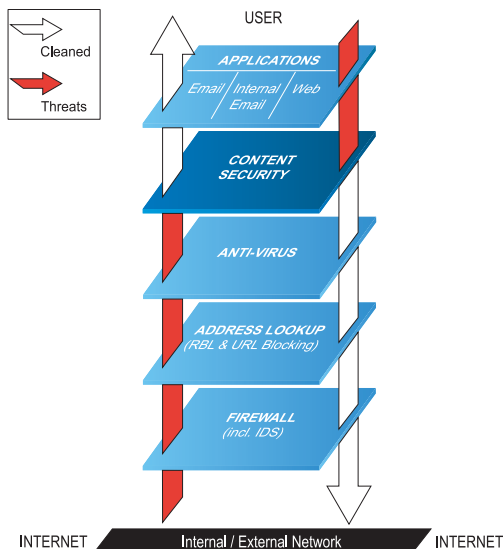

You can also add your own images to the database, ensuring that emails including confidential images, such as blueprint designs, can automatically be detected and blocked.
